Terms and Conditions

- 1) All vendors shall be licensed or otherwise authorized to conduct business in the State of Massachusetts, if required. Vendors are responsible for their own tax, permits and license liabilities. Vendors shall display copies of all applicable licenses.
- 2) All vendors agree to exercise care in the use of facilities and property of the Town of Winchendon, and any personal or business property within the market area. All vendors shall refrain from smoking during Market hours. Please leave your space as clean as you found it.
- 3) Vendor space provided is a 10x10 space. Vendors are responsible for bringing their own table, chairs, and displays. Pop up canopies must be staked down appropriately, or weighed down with adequate weights on the canopy legs at all times. Vendor set up begins 1 hour before market start time. Vendors may drive on paved walkways to unload/load (do not drive on grass) and all vehicles must be removed to street parking prior to start of market. Winchendon Farmers Market is located at GAR Park on Murdock Ave, Winchendon. Please check in with a Market Manager upon arrival.
- 4) The Market Managers reserve the right to take on new vendors throughout the season to assure our customers a good variety of items at any point in the season.
- 5) This is a Producer-Only Market. All items sold shall be grown or produced by the vendors, and compliance may be tested by on-site visits. Arrangements may be made to offer certain products from another farm, if they are not supplied by one of our members. Vendors shall obtain approval from a Market Manager before you arrive with a foreign product. Any produce brought in from another producer shall be labeled with the name and town of said producer.
- 6) Vendors may use the words "Certified Organic" only if they are certified. Other terms that may be used for practices that are natural but uncertified include "Grown Organically", "Organic Farming Practices Used".
- 7) Vendors are encouraged to follow the market on social media for updates. You are invited to reshare posts, and to tag the market in your own social media posts.
- 8) The Market is subject to cancellation due to weather. A vendor is requested to stay until the Market closes. In the event that a vendor has sold out, that vendor may choose to leave before the close of market hours, but no driving on walkways to load until the end of the market hours.
- 9) Any violation of these terms and conditions, as determined by the Market Manager, shall subject the violator to corrective actions up to removal from the market.
